#### BYLAWS OF THE SEXUAL HEALTH ALLIANCE

#### **OF LINN & JOHNSON COUNTIES**

### Article I: Name

This organization shall be known as the Sexual Health Alliance of Linn & Johnson Counties (hereto referred to as the Alliance).

### **Article II: Purpose/Vision**

The Alliance is a coalition of community agencies, organizations, and individuals who seek to affect positive change within their communities in the areas of sexual health, sexually transmitted diseases (STD) and HIV/ AIDS prevention. The Alliance understands that STDs and HIV/AIDS are present in our communities and have deleterious effects to the health of our residents. As an alliance, we value comprehensive sex education, which promotes both abstinence and age-appropriate, medically accurate information about contraception, prophylactics, and sexual health. The Alliance believes in an inclusive community and is accepting of all individuals regardless of differences.

Our mission is "A comprehensive collaboration dedicated to the sexual health of our communities."

### Article III: Membership/Voting

- A) In no aspect of its activities shall there be any difference in the treatment of persons on the basis of race, national origin, color, creed, religion, sex, age, ability, veteran status, real or perceived sexual orientation, gender identity, or associational preference, or any other classification which would deprive the person of consideration as an individual.
- B) Membership shall be open to all people who live, work, or volunteer in Linn or Johnson Counties who maintain a vested interest in combating STD and HIV infections in their local communities & promoting sexual health. This may include members from the fields of public health, sexual health, general medicine, nursing, student health services, aging services, and health promotion as well as representatives from support fields such as the lesbian, gay, bisexual, transgender, and queer communities, art communities, minority communities, and communities of faith. Individual members will need to sign a statement of individual commitment when they first join the Alliance in order to be able to vote and be considered an official member of the Alliance.
- C) Community Based Organization (CBOs) and local agencies will have no limitations on the number of members that may be sent to represent their organization at coalition meetings. However, voting will occur on an agency basis requiring that each agency appoint one voting member who will maintain voting responsibility. The appointment of said voting member shall be reported to the coalition Secretary for recordkeeping and should be updated promptly in the event of change.
  - a. In the event of a voting member's absence from a voting meeting, a proxy vote must be submitted via email or in writing to the coalition secretary no later than 24 hours in advance of the scheduled meeting time.
- D) Membership is open to any member of the public, who lives, works or volunteers in Linn or Johnson counties, who has a vested interest in the cause and mission of the coalition. Seated members are expected to actively recruit new members from their respective communities to take part in the coalition. Membership revocation, while unanticipated, will be handled by the executive board on a case-by-case basis.

### **Article IV: Officers and Duties**

The Alliance shall be led by an executive board comprised of no less than three persons elected and appointed by the voting members as deemed appropriate in Article V of this document.

A) President

a. The President shall be vested with the responsibility of calling and leading all Alliance meetings, both Executive and general. The President will manage regular e-mail correspondence with members (other than the minutes and agenda).

### B) County Representatives

Two County Representatives shall be elected: One representing Linn and the other Johnson County. Unlike other Executive positions, to which any voting member of the Alliance may be elected, eligibility for County Representatives shall be limited to representatives for the four agencies (Planned Parenthood, United Action for Youth (UAY), Johnson County Public Health, and Linn County Public Health—as identified in the 2016 Member Survey) who have vested interest in the Alliance's success.

Each County Representative shall share the responsibilities of keeping inventory and safeguarding Alliance materials (e.g., literature, tabling items, etc.). Additionally, County Representatives will be expected to secure meetings locations within in their respective counties and preside over those meetings whenever the President is unable to attend.

- Johnson County Representative
   The Johnson County Representative shall organize booking and preparation of all Johnson County meeting spaces
   as well as manage the Alliance's website.
- Linn County Representatives
   The Linn County Representative shall organize booking and preparation of all Linn County meeting spaces as well as manage the Coalition's social media pages.

### C) Secretary

a. The Secretary shall keep an accurate record of all meetings, votes, and of all membership/committee participation.

The Secretary shall be responsible for the compilation of minutes and their distribution in a timely manner following each meeting.

### D) Treasurer

a. The Treasurer shall receive all funds for the coalition and maintain records or all receipts and transactions. The Treasurer shall report current account balances at each executive meeting.

### E) Historian

a. The Historian shall be elected on an as-needed basis. The Historian is responsible for archiving coalition activities.

### **Article V: Meetings**

- A) Coalition meetings shall occur no less than once per quarter—and more frequently should the executive board feel it is appropriate.
- B) Due to the nature of participation Quorum shall not be required to conduct official business. A majority of votes (50% + 1) will be the necessary standard for passage on all proposed business during normal business meetings.
- C) Scheduled coalition meetings shall be held rotationally between designated sites within Johnson and Linn Counties.
- D) Meetings shall be led by the President, or a designated delegate in his/her Absence, and follow the guide of Robert Rules of Order.

### **Article VI: Elections**

- A) Executive board elections shall be held once per calendar year at the last or first coalition meeting of the year.
- B) Members will be notified one meeting in advance of upcoming or impending elections with a reminder to be included (via email) in the distributed minutes from that meeting.

- C) Members will be eligible to vote in any election of the executive board if they meet the following criteria:
  - a) The member has been a voting member of the coalition for no less than two consecutive general meetings prior to the election of the executive board.
- D) Should a vacancy occur on the executive board at a time not consistent with scheduled elections remaining board members shall call a special election which may take place at a normal business meeting as long as the voting members are given proper notice of one calendar month prior to it taking place.

### **Article VII: Finances**

Finances shall be considered any monetary asset maintained by the coalition. Finances shall be handled with transparency by the elected Treasurer and reported upon quarterly at general business meetings of the coalition.

### **Article VIII: Amendments**

- A) Any member or the executive board may propose amendments to this document at any time by presenting a written modification to the executive board and requesting that a discussion be placed on the agenda for an upcoming coalition meeting.
- B) Proposed amendments shall be distributed, via email, to all eligible voting members following introduction and discussion.
- C) Voting on proposed amendments shall occur at the next business meeting following the amendment's introduction, initial reading, and electronic distribution.
- D) A supermajority (2/3) vote of all eligible voting members shall be required to satisfactorily amend this document.

### **Article IX: Ratification**

- A) The proposed version of this document shall be introduced to Coalition members at a general business meeting, distributed via email for review after the initial reading, and scheduled for discussion and vote at the Coalition meeting following the initial introduction.
- B) A supermajority (2/3) vote of all seated voting members shall be required for the adaptation of this document.
